## Gift Aid It

Gift Aid is a government scheme which allows charities to reclaim the basic rate of tax that has already been paid by individuals on donations. By ticking the Gift Aid declaration box you can increase the value of the donation up to 28% without it costing you an extra penny. To be eligible you must pay Income tax or Capital Gains tax and you must have paid enough of these taxes in the year to cover the amount the Pankhurst Centre will reclaim.

### DECLARATION
